Section 1. That in the 2019 Annual Operating Budget for Craighead County, Funds 3593 and 3595 were established and funded by appropriation with transfers from Fund 2000, County Road Fund, as needed. These Culverts Mitigation Grant Funds were approved for funding through the mitigation grant department and funded with a 50/50 match funding to help alleviate repetitive flooding and road damage issues in the future. Arkansas Department of Legislative Audit recommends that special funds be established in the annual operating budget to allow for accurate expenditures and revenue tracking.

Section 2. Section 3. That the County Treasurer shall make the appropriate transfer from Fund 2000, County Road unappropriated funds into Funds 3593 and 3595 to support these special revenue funds in day to day operations as listed below:
