Amend Appropriation Ordinance 2020-22, 2021 Craighead County Annual Operating Budget regarding পাঁট চিটান ওয়াইনিভিচ্ছান for other purposes and an Emergency Clause.

WHEREAS, Craighead County has agreed to utilize the Johanson salary survey for the 2021 Annual Operating Budget based on recommendations and with the adoption of the 2021 Annual Operating Budget, the Quorum Court agreed to review the salary survey during 2021 for possible salary increases to the midpoint of the Johanson study, and

WHEREAS, the Craighead County Quorum Court conducted a recent review of the financial status of Craighead County, and

WHEREAS, it was determined that all county line item funds of salaries and benefits contain sufficient funds to implement the salary adjustments, and

WHEREAS, the new salary adjustments will be contingent as stated in the Craighead County Salary Administration Policy in regards to the individual hire status, and

WHEREAS, an Appropriation Ordinance is necessary in connection with the Craighead County Salary Administration Policy, of which the Personnel Compensation Plan is based upon the annual operating budget as appropriated by the Quorum Court;

Now therefore be it Ordained by the Quorum Court of Craighead County, State of Arkansas as follows:

Section 1. That the following salary and benefit budget adjustments be incorporated into the current budget effective Tuesday, July 13, 2021 through the remainder of year.
