An Ordinance amending the 2021 Annual Operating Budget to add Fund 3540, Department 0500, FEMA Hazard Mitigation Grant Program to include grant monies that have become available to Craighead County through the FEMA Hazard Mitigation Grant Program (HMGP) and administered through the Arkansas Department of Emergency Management (ADEM) to update the Craighead County Hazard Mitigation Plan.


SECTION 1. That Hazard Mitigation Project Grant monies in the amount of \$35,000 have become available to Craighead County with a 25% local county match of \$8,750 and 75% Federal share match of \$26,250 and will be used to pay for contractual services to gather data, update, and develop a fully approved hazard mitigation plan. This Project plan update will allow the Federal Emergency Management Agency to continue to assist Craighead County when disasters occur and will allow the County to help prevent potential disasters by pre-planning and taking preventative measures to avoid potential future disasters.


SECTION 2. That this new fund will be created in the 2021 Annual Operating Budget to allow for accurate tracking, disbursing, and accounting of the FEMA Hazard Mitigation Grant Program monies by the Office of Emergency Management and will include projected revenues and budget totals as described below.
