## BE IT ENACTED BY THE QUORUM COURT OF CRAIGHEAD COUNTY, ARKANSAS; AN ORDINANCE TO BE ENTITLED:

An Ordinance amending the 2023 Annual Operating Budget to add Fund 3598, Department 0422 to include Administrative Office of the Courts (AOC) Grant monies that were awarded through the Court Security Grant and should be incorporated into the Craighead County Annual Operating Budget and processed according to grant requirements for receiving and disbursing of these grant funds.

**Section 1.** That State Grant monies have become available through the AOC for a Court Security Grant to purchase a panic button for the Circuit and District Courts in the amount of \$19,505.50. The current system is unable to be expanded and there are currently Juvenile Court offices that do not have a panic button in close proximity. With the Courtroom Expansion adding courtrooms, the need for a panic button system that can have buttons added is imperative.

**Section 2.** That these funds are considered to be special revenue and will be created in the Annual Operating Budget to allow for accurate tracking, disbursing, and accounting of court security grant funds and will include budget totals as described below.
