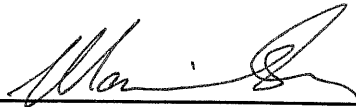

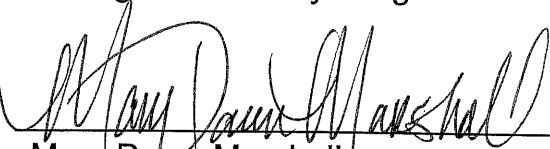
WHEREAS; the Craighead County Solid Waste Disposal Authority's proposed 2024 budget is attached.
