An Ordinance amending the 2024 Annual Operating Budget to add additional line Item 1015, Uniform Allowance, into designated departments and line item funds transfer with no increase to the operating budget, as COUNTY & PROBATE COURT CLERK recommended by Legislative Audit to help eliminate year end W-2 balancing issues, and for other purposes.

SECTION 1. That due to some employees receiving uniform allowance benefits and not being reflected correctly on the W-2 forms at the end of the year, is causing discrepancies and balancing issues, and that Legislative Audit has recommended that this additional line be incorporated into the current 2024 operating budget and future budgets in order to help eliminate this issue.

SECTION 2. This additional line item and money transfers will be incorporated into the 2024 Operating budget according to the offices/departments as outline below. Money transfers within each Office/Department into the new line will result with no additional funds being appropriated into the current operating budget.
