Craighead County Ordinance No. 2025- 9

Be It Enacted By the Quorum Court of Craighead County, State of Arkansas:

An Ordinance to designate a fund to designate funds for utilization in connection with Ordinance 2022-14 for reserves and maintenance needs for Craighead County Property Owners' Multipurpose Improvement District #2 and to Declare an Emergency, and for Other Purposes

WHEREAS, the Craighead County Quorum Court passed Ordinance 2022-14 establishing procedures for a Non Municipal Domestic Sewage Treatment System to be located in the unincorporated areas of Craighead County, State of Arkansas; and

WHEREAS, funds have been received to allow for operational needs as a surety for the operation of the Craighead County Property Owners' Multipurpose Improvement District #2, and

WHEREAS, the County of Craighead shall designate funds for placement on the books of Craighead County.

SECTION 1.

Affirmation. It comes before this Court that there is a need to establish two (2) funds for the designation of funds for the operational needs of Craighead County Property Owners' Multipurpose Improvement District #2. This Court recognizes and affirms the need for such funds to properly account for and control all expenditures made.

SECTION 2.

Establishment of Funds. There is hereby created on the books of the Craighead County Treasurer and the books of the Craighead County Clerk a fund to be known as **Craighead County Multipurpose Improvements (LOC)**. The fund number is **6494** as assigned by Arkansas Legislative Audit.

There is hereby created on the books of the Craighead County Treasurer and the books of the Craighead County Clerk a fund to be known as **Craighead County Property Owners' Multipurpose Improvement District #2**. The fund number is **6850** as assigned by Arkansas Legislative Audit.

Any transfer codes, office/department codes, and expenditure codes are to be assigned locally using the County Financial Management System per the direction of Arkansas Legislative Audit.


SECTION 3.


Operation of Fund. The **Craighead County Multipurpose Improvements (LOC)** and **Craighead County Property Owners' Multipurpose Improvement District #2** are subject to all the normal county budgeting, appropriation and expenditure regulations of Title 14 of Arkansas Code Annotated and the County Financial Management System. The County agrees to use funds in connection with the purposes set forth in Ordinance 2022-14, or as amended, and Arkansas Code Section 14-236-102, *et*.

seq. and to establish a designated third party to review the needs and ensure and promote expenditure of funds in spirit of the Ordinance and to comply with requirements of the Ordinance and laws within the Arkansas Sewage Disposal Systems Act.

Emergency Clause. It is found by this Court that the receipt is imminent or already received making it necessary to establish the funds in order to properly track the revenue and appropriated expenditures. Therefore, an emergency is declared to exist and this ordinance shall be in full force and effect from the date of passage and approval.
