Ordinance No. 2013 - ____

AN ORDINANCE DESIGNATING THE CRAIGHEAD COUNTY OFFICE TO COLLECT THE FINES AND CIVIL PENALTIES ASSESSED AGAINST DEFENDANTS IN THE CIRCUIT COURT OF CRAIGHEAD COUNTY, ARKANSAS.

WHEREAS, THERE IS A NEED BY THE CRAIGHEAD QUORUM COURT OF CRAIGHEAD COUNTY, ARKANSAS, TO DESIGNATE AN OFFICIAL TO COLLECT THE FINES AND CIVIL PENALTIES ASSESSED AGAINST DEFENDANTS TO THE CIRCUIT COURTS OF CRAIGHEAD COUNTY, ARKANSAS.

NOW THEREFORE BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF CRAIGHEAD, STATE OF ARKANSAS THAT:

SECTION 1: THE CRAIGHEAD COUNTY SHERIFF IS HEREBY DESIGNATED TO COLLECT ALL FINES AND CIVIL PENALTIES ASSESSED AGAINST ANY AND ALL DEFENDANTS IN THE CRAIGHEAD COUNTY CIRCUIT, PURSUANT TO ACT 1262 OF 1995.

SECTION 2: THE CRAIGHEAD COUNTY DISTRICT COURT CLERK IS HEREBY DESIGNATED TO COLLECT FINES ASSESSED IN MUNICIPAL, DISTRICT, AND CITY COURTS OR POLICE COURTS IN CRAIGHEAD COUNTY, ARKANSAS, PURSUANT TO ACT 1262 OF 1995 WITH THE COUNTY JUDGE DETERMINING THE METHOD OF COLLECTION FOR OUTSTANDING FINES AND FEES.
