In Collector Phillip's absence, Tony Thomas updated the committee on tax collections with numbers presented by the collector. Current collections are slightly less than this time a year ago, with delinquent real and personal collections up from last year.

Tony Thomas updated the committee concerning the fixed assets listing of county owned land and buildings. Each property was reviewed in detail as to occupancy, ownership, and use.

Justice Longmire again inquired as to why the Nursing Center Board of Directors would not come to the Quorum Court Meeting and update the committee as to the operations of the facility.

WHEREAS, ACT 742 OF THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS, STATES THAT THE COUNTY JUDGE OF EACH COUNTY IS THE APPROPRIATE PERSON TO APPOINT AND REAPPOINT BOARD MEMBERS TO THE CRAIGHEAD COUNTY/JONESBORO PUBLIC LIBRARY BOARD OF DIRECTORS.

WHEREAS, KEVIN MULHOLLAND CURRENTLY SERVES ON THE CRAIGHEAD AND JONESBORO LIBRARY BOARD OF DIRECTORS, HAVING FILLED OUT A PARTIAL TERM OF VACANCY. MR. MULHOLLAND HAS GRACIOUSLY AGREED TO SERVE AN ADDITIONAL TERM ON THE BOARD OF DIRECTORS.

RESOLUTION No. _____

**RESOLUTION OF THE QUORUM COURT OF CRAIGHEAD COUNTY, ARKANSAS,
CERTIFYING LOCAL GOVERNMENT ENDORSEMENT OF BUSINESS TO PARTICIPATE IN
THE TAX BACK PROGRAM (AS AUTHORIZED BY SECTION 15-4-2706(d) OF THE
CONSOLIDATED INCENTIVE ACT OF 2003).**

WHEREAS, in order to be considered for participation in the Tax Back Program, the local government must endorse a business to participate in the Tax Back Program; and

WHEREAS, the local government must authorize the refund of local sales and use tax as provided in the Consolidated Incentive Act of 2003; and

WHEREAS, said endorsement must be made on specific form available from the Arkansas Economic Development Commission; and

WHEREAS, FMH Conveyors LLC, to have a facility at 9701 E. Highland Dr., Jonesboro, Arkansas, has sought to participate in the program and more specifically has requested benefits accruing from construction and adding equipment to the specific facility; and

WHEREAS, FMH Conveyors LLC, has agreed to furnish the local government all necessary information for compliance.

NOW THEREFORE BE IT RESOLVED BY THE QUORUM COURT OF CRAIGHEAD COUNTY, ARKANSAS, THAT:

1. FMH Conveyors LLC, be endorsed by the Quorum Court of Craighead County, Arkansas for benefits from the sales & use tax refunds as provided by Section 15-4-2706(d) of the Consolidated Incentive Act of 2003.
2. The Department of Finance and Administration is authorized to refund local sales and use taxes to FMH Conveyors LLC.
3. This resolution shall take effect immediately.
