Third reading was done of An Ordinance to request the Analysis for Alternative County Government Organization for the Consolidation of the Office of Treasurer and Collector, and for other purposes. A motion to read by title only was made by Justice Barnes and seconded by Justice Cook. All present were in favor, and the Ordinance was read by title only. Justice Barnes stated he looks forward to reading the analysis when it comes back. Roll was taken and all present were in favor and the Ordinance passed.

NEW BUSINESS

A Resolution of the Quorum Court of Craighead County appointing Mr. Harry Truman Moore to solemnize the marriage of Kathryn Cherry and Robert Garant was read. A motion to approve was made by Justice Cook and seconded by Justice Forrest. All present were in favor and the Resolution passed.

A Resolution recommending the reappointment to a board, Cogan Ford, member to the Board of Directors of Bono Fire Protection District was read. A motion to approve was made by Justice Cline and seconded by Justice Tennison.

First reading was done of **An Ordinance Amending the Craighead County Salary Administration Policy to allow the Craighead County Sheriff and the Craighead County Detention Center to hire personnel with verifiable experience and the salary midpoint.**

A motion to approve the first reading was made by Justice Cook and seconded by Justice Forrest. Judge Day asked for any Public Comment or questions. Sheriff Boyd stated he would answer any questions.

Public Comment:

Matt Redman asked what the nature of the Emergency Clause and to suspend rules and move to second reading was. Justice Forrest stated that after talking with Sheriff Boyd, we as a County have lost 4 Sheriff Deputies to Arkansas State Police and one to retirement this month, and we are now left without those Deputies cruising the streets of the County. He also stated this is the reason for the Emergency Clause. Sheriff Boyd stated that within the next 30 days there will be five openings for Deputies and that he is looking at interviewing candidates with up to 10 years' experience. He added that with current policy they would hire in at \$6,000 less. Justice Longmire asked what this will bring their starting pay to if the Ordinance passes. Sheriff Boyd said it would be around \$52,800 whereas Arkansas State Police start at around \$72,000.

A vote was taken to approve the first reading, and all present were in favor.

A motion to suspend rules and put on second reading by title only was made by Justice Cook and seconded by Justice Pasmore. All present were in favor, and the Ordinance was read by title only for second reading.

A motion to suspend rules and put on third reading was made by Justice Cook and seconded by Justice Pasmore. All present were in favor.

Justice Cline made a motion to read by title only for third reading and it was seconded by Justice Cook. All present were in favor. The Ordinance was then read by title only. A motion to approve the Ordinance was made by Justice Cook and seconded by Justice Williams. A vote was taken, and all present were in favor and the Ordinance passed.
