## Finance Committee Minutes September 12, 2022

Chairman Longmire called the early Finance Committee meeting to order at 5:00 pm. Present were Justices Pasmore, Cook, Pearcy and Weinstock, Collector Eddington, and Treasurer McNatt.

Collector Eddington gave the report on August's tax collections. Total current taxes collected was 6.2% higher than the previous August.

Treasurer McNatt reported on August's financial reports. There is 56.31% of the budget remaining for the year. The Road Fund ended the month with \$7.08 million, County General had \$7.03 million at month end, and the Capital Fund had \$2.74 million remaining. Sales tax collections were 10.17% higher than previous year. Treasurer McNatt presented the YTD comparison through August 2022. Craighead County is \$1.2 weaker than prior year, due to higher costs.

Chairman Longmire read the Appropriation Ordinance for Fund 1006, to reimburse Fund 1000, County General for payroll expenses and benefits. After some discussion, a motion was made by Justice Pasmore and seconded by Justice Pearcy. The motion passed and will move to the full court for approval.

With no other business, Justice Cook made the motion to adjourn, seconded by Justice Weinstock. All were in favor and the Finance Committee adjourned at 5:18 pm.
