NEW BUSINESS:


A Resolution was read to declare the purchase of four Chevy Tahoe's for the Sheriff's Department exempt from bid process, per ACA 14-22-106, 8A. A motion to accept made by Justice Cline and seconded by Justice Pasmore. Judge Day asked for any questions or comments. Justice Longmire asked how much will the County pay for each Tahoe? Judge Day stated that they are \$43,000 each. Passed unanimously.

A Resolution to support Southridge Fire Protection District's application for Arkansas Rural Fire Community Grant Funding was read. A motion was made by Justice Tennison and seconded by Justice Longmire. Judge Day asked for any questions or comments. Justice Lewis asked where Southridge Fire is located? Judge Day stated that it is South Hwy 1, past 55, down by the Softball Complex. Passed unanimously.

An Appropriation Ordinance for Fund 3539, Hazard Mitigation Grant, CR 7628-7629 was read. A motion was made by Justice Longmire and seconded by Justice Tennison. Judge Day asked for any questions or comments. Roll was called and passed unanimously.

An Appropriation Ordinance regarding 2021 Fund transfers was read. A motion was made by Justice Pasmore and seconded by Justice Pearcy. Justice Weinstock asked where the adjustments come from? Judge Day stated that it comes from court orders that he signs. Roll was called and passed unanimously.

An Appropriation Ordinance to increase part-time allowable rate of pay to \$15/hour was read. A motion was made by Justice Weinstock and seconded by Justice Pasmore. Judge Day asked for any questions or comments. Justice Lewis asked what the old rate was? Judge Day said \$13/hour. Roll was called and passed unanimously.

An Ordinance to enact a Code of Ordinances for Craighead County, emergency clause was read. A motion was made by Justice Cline and seconded by Justice Couch. Judge Day asked for any questions or comments. Roll was called and passed unanimously.

An Ordinance to establish Fund 1006, ARPA Revenue Replacement Fund, with emergency clause was read. A motion was made by Justice Cline and seconded by Justice Noel. Judge Day asked for any questions or comments. Roll was called and passed unanimously.

An Ordinance to revise Salary Administration Policy for Promotional Increase Eligibility, with emergency clause was read. A motion was made by Justice Rogers and seconded by Justice Tennison. Judge Day asked for any questions or comments. Roll was called and passed unanimously.
