Road Committee minutes 8/8/2022

Chairman Cline called the meeting to order at 5:36 pm. Those present were Justice Couch, Justice Tennison, Justice Lewis, Road Superintendent John James, and County Judge Marvin Day. John James gave an update on road work being done. He shared that the crew is finished putting shoulders on Rogers Chapel Road and they are sealing CR 118, CR 333, and others. Craighead County was recently awarded a Hazard Mitigation Grant to do work on CR 342.

With no other business, Justice Tennison made a motion to adjourn, 2nd by Justice Couch. Motion passed and the committee adjourned at 5:50 pm.

Public Service Committee Minutes 8/8/2022

The Public Service meeting was called to order at 5:39 pm by Chairman Richard Rogers. Those in attendance were Justice Williams, Justice Noel, and Justice Price.

The only item on the agenda was the reappointment of Mr. Kris Richardson to the Craighead County Law Library Board. Motion to approve was made by Justice Noel and 2nd by Justice Williams. Motion passed to move to the full court for approval.

With no other business, a motion to adjourn was made by Justice Williams and 2nd by Justice Noel. Meeting adjourned at 5:41 pm.

Finance Committee Minutes August 8, 2022

Chairman Longmire called the Finance Committee meeting to order at 5:38 pm. Present were Justices Pasmore, Cook, Pearcy and Weinstock, Collector Eddington, and Treasurer McNatt. Also present were Mary Dawn Marshall, and Rachel Cook.

Collector Eddington gave the report on July's tax collections. Total current taxes collected was 5.9% higher than the previous July.

Treasurer McNatt reported on July's financial reports. There is 59% of the budget remaining for the year. Treasurer McNatt presented the YTD comparison through July 2022. Craighead County is \$150,518.74 stronger than prior year. Regarding the cost of self-funded insurance, there have been payments made totaling \$954,343.59 since January.

Chairman Longmire read the Appropriation Ordinance for Fund 2999, FY23 State Hazard Mitigation Grant, CR 342. A motion was made by Justice Cook and seconded by Justice Pasmore. The motion passed and will move to the full court for approval.

With no other business, Justice Weinstock made the motion to adjourn, seconded by Justice Cook. All were in favor and the Finance Committee adjourned at 5:45 pm.
