December 7, 2021 Quorum Court Minutes

13 Justices of the Peace were present. Also present were Lesli Penny, Terry McNatt, and Marty Boyd.

Judge Day called the meeting to order at 5:30PM.

Assembly and Pledge of Allegiance.

First order of business was approval of Quorum Court minutes from November 22, 2021. A motion to accept was made by Justice Williams and seconded by Justice Pasmore. Judge Day took a vote and it passed unanimously.

OLD BUSINESS:

Not any.

NEW BUSINESS:

An Appropriation Ordinance was read to adopt the 2022 Craighead County Operating Budget. A motion to accept made by Justice Cline and seconded by Justice Rogers. Judge Day asked for any questions or comments. Justice Weinstock asked how many automobiles are covered by the County? Judge Day stated that the Sheriff's Department has close to 50, the Road Department has about 30-35, approximately 80-100 vehicles altogether. Judge Day also explained how expenses are different during a big election year. County Clerk, Lesli Penny, explained how publishing ordinances is so expensive. Justice Weinstock asked Mrs. Penny about voter ID cards that are mailed out. Mrs. Penny explained that any time a change is made in Power Profile, voter cards are automatically generated. Justice Weinstock asked if the cards come out of Mrs. Penny's budget or Election Budget. Mrs. Penny stated they come out of her budget. Roll was called and passed unanimously.

An Addendum to Amend 2022 Proposed Budget was read. A motion to amend was made by Justice Longmire and seconded by Justice Pasmore. Roll was called and passed unanimously.

ANNOUNCEMENT:

Judge Day stated that it was the 80th Anniversary for Pearl Harbor Day. He wanted to thank all our Veterans for their service.

PUBLIC COMMENTS:

Not Any.

A motion was made to adjourn by Justice Cline and seconded by Justice Pasmore. Motion passed.

APPROPRIATION ORDINANCE 2021 - _____
