2022 COMBINED ANNUAL REPORT PURSUANT TO ACA \$14-86-103 AND \$14-86-2102

The commissioners of Willow Slough Drainage District submit the following as their annual report pursuant to ACA \$14-86-103 and \$14-86-2102 for the year ended December 31, 2021:

- The name of this district is Willow Slough Drainage
 District of Jackson and Craighead County, Arkansas.
 - 2. This district was formed on July 17, 1964.
- 3. This district was formed under the authority of 1909 Acts of Arkansas, No. 279 (ACA § 14-21-101 et seq).
- 4. Attached hereto as Exhibit A is a map of the district setting forth district boundaries. Attached as Exhibit B is an excerpt from the order entered July 17, 1964 and additional order entered March 16, 1965 setting forth the lands embraced within the district.
- 5. The district's commissioners and their addresses and terms of office are as follows:

- 6. This district has no vacancies in its board of commissioners.
- 7. Refer to Exhibits A and B for a map of the parcels of property located within the district.
- 8. The board of commissioners meets throughout the year on an as needed basis and annually between November 15 and January 15 each year. Meeting dates are generally established between November 1 and December 1.
- 9. The district maintains its ditch and right-of-way on an as needed basis in order to provide a drainage outlet within the district. Generally, it is necessary to mop and remove silt from time to time, to remove trees along the right-of-way, and to remove beaver dams and impediments within the ditch.
- 10. As of the date of this report the district has no outstanding contractual obligations.
 - 11. The district has no indebtedness.
- 12. Assessments for the district are collected with real estate ad valorem taxes by the Jackson County Tax Collector and Craighead County Tax Collector. Attached as Exhibit C is a listing of delinquent assessments as of February 28, 2022.

- 13. The benefits and damages for lands within the district have been established for many years. The cost of regular or routine reassessments is prohibitive. The commissioners act as assessors for the district on an as needed basis.
- 14. The county treasurers are directed to pay taxes by check payable to the district and forwarded to district attorney, Edward Boyce, 515 Second Street, Newport, AR 72112
- 15. The district does not routinely assess penalties, interest and costs but reserves the right to assess to the full extent of statutory authority.
- 16. The benefits and damages for lands within the district have been established for many years. The cost of regular or routine reassessments is prohibitive. The commissioners act as assessors for the district on an as needed basis.
- 17. Attache as Exhibit D is the district's annual accounting for the period ending December 31, 2021.




