YEAR TO DATE SALES AND USE TAX



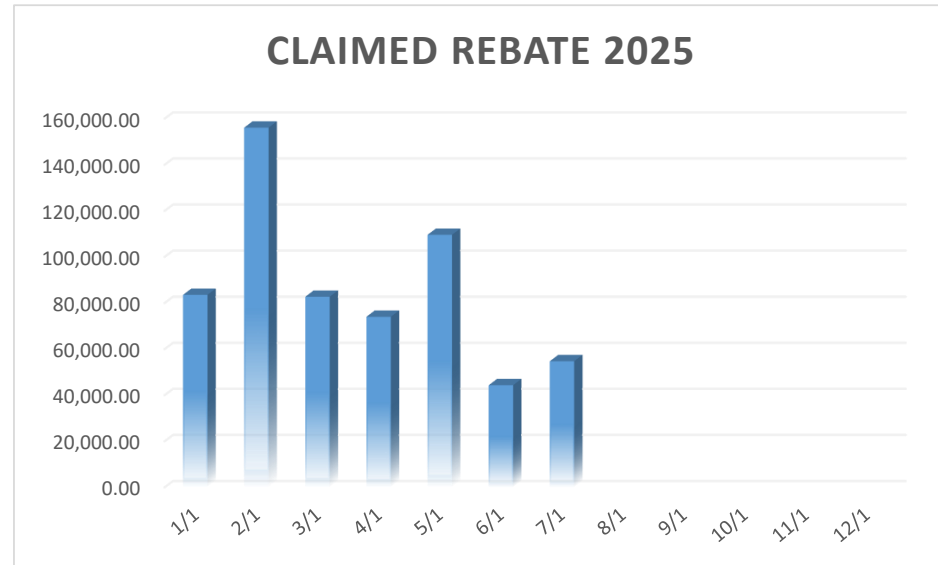

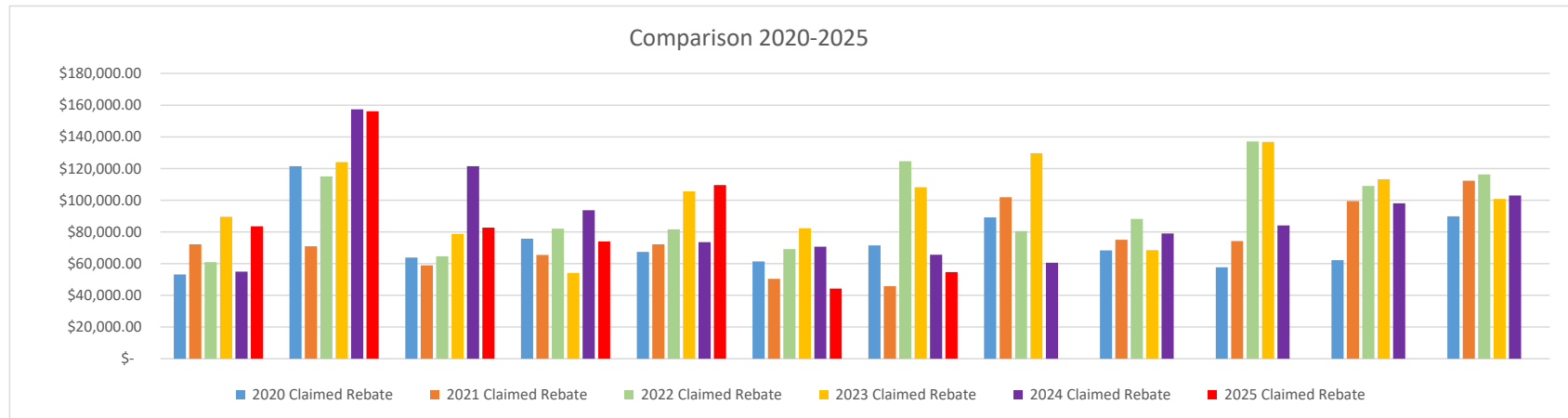
